Please be aware that I represent Mr. [REDACTED]. This cease and desist demand letter is to inform you that your harassing actions against Mr. [REDACTED] has become unbearable to him. Such anti-social behavior is completely unacceptable and will not be tolerated. This letter is to demand that your harassment must cease and desist immediately. Should you continue to pursue these activities in violation of this cease and desist demand letter, we will not hesitate to pursue legal action against you, including, but not limited to, civil action and/or criminal complaints.



This cease and desist letter demands that you immediately discontinue and do not at any point in the future under any circumstances do the following to Mr. [REDACTED]: speak to, contact, pursue, harass, attack, strike, bump into, brush up against, push, tap, grab, hold, threaten, telephone (via cellular or landline), instant message, page, fax, text, email, follow, stalk, shadow, disturb Mr. [REDACTED]'s peace, keep Mr. [REDACTED] under surveillance, hack his Facebook account, gather information about and/or block his movements at home, work, school, social gatherings or religious functions.

Please note that a copy of this letter and a record of its delivery will be stored. Note too that it is admissible as evidence in a court of law and will be used as such if need be in the future.

Also please note that my client is considering pursuing legal action against you, including, but not limited to, civil action and/or criminal complaints in connection with your battery upon him on the night of December 5, 2016 (approximately 1:00 AM December 6, 2015) the night you attended a student party at Williams College.
